

FUJIFILM INSTAX MINI INSTANT FILM January 2021 Sweepstakes

Official Sweepstakes Rules

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase will not increase your chances of winning. The FUJIFILM INSTAX MINI INSTANT FILM January 2021 Sweepstakes (the "Sweepstakes") is being conducted by FUJIFILM North America Corporation, 200 Summit Lake Drive, Valhalla, NY USA 10595, FUJIFILM Canada Inc., 600 Suffolk Ct., Mississauga, ON L5R 4G4, and their promotional agencies (the "Sponsors"). THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, OR ADMINISTERED BY, OR ASSOCIATED WITH, INSTAGRAM OR ANY OTHER SOCIAL MEDIA SITE. BY PARTICIPATING IN THIS SWEEPSTAKES, YOU ARE PROVIDING YOUR INFORMATION TO FUJIFILM NORTH AMERICA CORPORATION AND FUJIFILM CANADA INC., AND NOT TO INSTAGRAM OR ANY OTHER SOCIAL MEDIA ORGANIZATION.

2. Sweepstakes Period and Eligibility. The Sweepstakes begins and entries will be accepted commencing as of 9 a.m. on Tuesday, January 19, 2021. The Sweepstakes will close and no more entries will be accepted after Sunday, January 24, 2021 at 11:59 EDT (the "Sweepstakes Deadline," and the period between January 19 and January 24, 2021 while the Sweepstakes is in effect is referenced herein as the "Sweepstakes Period"). Random drawings to select 10 winners from among all eligible entries received as at the end of the Sweepstakes Period are anticipated to occur on or about Monday, January 25, 2021 at Sponsor's U.S. headquarters. A total of 10 winners will be chosen at random at that time from among all eligible entries received, with prize winners notified and the verification process commenced promptly thereafter. The verified winners will be announced in the comments of the Instagram post @fujifilm_instax_northamerica soon thereafter

The Sweepstakes is open only to legal residents of the USA and Canada (excluding Quebec) who are at least 16 years of age at time of entry and who hold a valid Instagram account. Employees and the immediate family members of Sponsor are not eligible to enter or win. Void in Puerto Rico, the Canadian province of Quebec and wherever prohibited by law. Entrants will also be asked to certify on the Sweepstakes Registration and Entry Form as to (i) and then as to which of (iii) and (iv) above they have complied with. Eligible entrants not wishing to meet (iii) and/or (iv) regarding Instagram following and tagging / comment posting may simply fill out the Sweepstakes Registration and Entry Form and certify as specified (meeting the requirements set forth in (i) and (ii) above). All entries and entrants (including Instagram account activity) are subject to verification by Sponsors. - **One (1) FUJIFILM INSTAX MINI instant film Value Pack (60 count) that consists of (3) Twin Packs of INSTAX MINI White-Bordered instant film (USD ARV: \$49.99, CDN ARV \$63.99)**

Total ARV of each prize package offered is USD \$92.98, and CDN \$118.98. Total ARV of all 10 prizes to be awarded in connection with this Sweepstakes is USD \$929.80, CDN \$1,189.80

Prize winner must provide a valid U.S. or Canada Street address (no P.O. boxes) for prize shipment/delivery. Prize may not be redeemed for cash, substituted or transferred by any winner; however, if any prize or prize component becomes unavailable or otherwise at Sponsors' option, the Sponsors reserve the right to unilaterally substitute a prize or prize component of equal or greater value.
